

Warren County Farmers Fair Open Colored Breed Show
Friday July 31, 2009
9:30 AM

Any exhibitor showing at the Warren County Farmers Fair must be in compliance with New Jersey Division of Animal Health recommendations for New Jersey fairs, shows and sales. All animals must be free from infectious or contagious disease.

1. All entries must be submitted on the printed entry form (or copies of it) furnished by the Warren County Farmers Fair. All information and signatures asked for on the entry form must be furnished. Entries will not be accepted unless this information is provided. Production forms of each milking animal must be presented before 8:00 AM on the day of the show.
2. All exhibitors will pay in advance an entry fee of \$5.00 for each animal entered in the open shows and an additional \$1.00 fee for substitutions (you may substitute a cow for a cow or a calf for a calf). Post entries will be charged \$10.00 per animal and will not be accepted after 8:00 AM on the day the animals are to be shown. Checks should be made payable to the Warren County Farmers Fair Association and are due July 24, 2009.
3. Exhibitors will receive one exhibitor pass for the back gate to gain access to loading and unloading of animals.
4. All animals must be on the grounds by 8:00 AM the morning of the show. All exhibitors are asked to remain on the grounds until 7:00 PM the evening of the show. Animals may remain through Saturday August 1, 2009, however, **UPON REMOVAL OF YOUR ANIMALS – AREA MUST BE CLEANED UP.**
5. A valid (official) Certificate of Veterinary Inspection (CVI) signed by an accredited New Jersey Veterinarian must accompany all native New Jersey Animals. The CVI must indicate that all animals of the species to be exhibited on the exhibitor's premises have been observed by a veterinarian and found to be free of any signs of infectious or contagious diseases. The official New Jersey Certificate of Veterinarian Inspection is valid for 30 days in New Jersey. Cattle originating from other states must be accompanied by an official interstate Certificate of Veterinary Inspection in compliance with New Jersey's import regulations.
6. All domestic animals requiring CVI for exhibition must be individually identified by one of the acceptable species methods and it must be listed on the health certificate. If any additional identification is present, it should also be listed.
7. New Jersey exhibitors do not need brucellosis or tuberculosis certificates.
8. All female animals equal to or greater than four months of age should be calf hood vaccinated, but this is not required for Northeast animals. All animals must be current on Bovine Respiratory Disease complex (shipping fever) vaccination, which includes at least IBRK, PI3, BVD, and BRSV with dates of inoculation and product name recorded on the health certificate. It is strongly recommended that all animals exhibited be vaccinated against rabies. These will be checked with the registration papers. Check with your veterinarian for any updated tests that are required by the New Jersey Department of Animal Health.
9. Registration papers must be checked before your animals enter the show ring and must be available at all times. The New Jersey CVI or official interstate CVI for animals being brought from other states is required from each animal shown. (Please note that more than one animal can be recorded on a certificate). It is the exhibitor's responsibility to see that the papers are checked. If your registration papers have not been received by this date, it is advisable for you to call your breed association for verification of registry and/or transfer. Records will be checked before you enter the show ring. Proof of registration animals in owners name is required. Registration papers with agreeing markings or tattoos must be available when the animals arrive on the grounds. Animals must be registered and/or transferred and entered in the name of the owner. Junior Exhibitors animals that are leased by a Junior Exhibitor must be leased by May 1, 2009 and have a copy of the lease agreement available at all times.

10. Each animal entered can only be entered in one of the age classes. For example, a cow entered in the 5-year-old class may not be entered in the 125,000 classes or dry cow class. The Committee reserves the right to combine classes at their own discretion for balanced competition of entries received. All milking fall yearlings will compete in the Junior Two-Year-Old Class. All cows entered in milking or dry cow classes must have been fresh at least once. Except for two year olds, which will be shown in their respective two-year-old class.
11. The Warren County Farmers Fair Association will provide bedding for exhibitors. It is up to the exhibitors to bring feed, hay, utensils and equipment. Also it is the responsibility of the exhibitor to feed and water their animals.
12. **All walkways must be kept clear of equipment, supplies, debris, etc.**, during your entire stay at the Warren County Farmers Fair. At no time may any walkways be roped off in the exhibitor barns.
13. Medical waste must not be put in with the manure or trashcans on the grounds. Please dispose of needles properly by taking them home.
14. Exhibitors will be expected to display or parade their animals as directed by the superintendent and to accept conditions as provided without controversy. Non-compliance will result in forfeiture of premiums. This display is held for educational purposes, and animals must be kept in show shape.
15. Exhibitors shall be neatly dressed when exhibiting and wear clean clothes.
16. The committee reserves the right to bar from any show unruly animals or animals of decidedly inferior conformation and type or animals not meeting the health standards.
17. Bathroom and shower facilities located in the livestock area are available to all exhibitors.
18. The Open Colored Breed Show is open to any breeder from any county or state.
19. **PREMIUMS will be handed out the day of the show unless the animal is post entered – premiums for post entered animals may be mailed.**
20. Premiums will be paid in all type classes, special classes and showmanship classes.
21. Trophies will be given for Junior & Reserve Junior, Senior & Reserve Senior, Grand and Reserve Grand Champions in each breed.
22. The Supreme Champion will receive a Premium of \$100.00 and a trophy.
23. **All SPECIAL CLASS ENTRIES MUST BE MADE BY JULY 24, 2009. NO POST OR SUBSTITUTIONS ENTRIES FOR THESE CLASSES WILL BE ACCEPTED.**
24. All exhibitors are responsible to carry a manure bucket to and from the barns. All exhibitors must clean out there area immediately before leaving the grounds; failure to do so may result in loss premiums.

NOTE: Entry fee is \$5.00 per animal with that single fee, that animal can be entered in as many classes as the owner sees fit. – Post Entries \$10.00.

5. Winter Heifer Calf – born 12/1/08 through 2/29/09
6. Fall Heifer Calf – born 9/1/08 through 11/30/08
7. Summer Yearling – born 6/1/08 through 8/31/08
8. Spring Yearling – born 3/1/08 through 5/31/08
9. Winter Yearling - born 12/1/07 through 2/28/08
10. Fall Yearling – born 9/1/07 through 11/30/07
Milking fall yearlings will compete in the junior 2 year old class.
11. Junior and Reserve Junior Champion

Senior Female:

All animals entered in milking or dry cow classes MUST have been fresh at least once.

(Except for 2-year-old animals)

- 12. Junior 2 year old – born 3/1/07 through 8/31/07
- 13. Senior 2 year old – born 9/1/06 through 2/28/07
- 14. Junior 3 year old – born 3/1/06 through 8/31/06
- 15. Senior 3 year old – born 9/1/05 through 2/28/06
- 16. Four Year old – born 9/1/04 through 8/31/05
- 17. Five Year old – born 9/1/03 through 8/31/04
- 18. Aged Cows – born before 8/31/003
- 19. Junior Dry Cow – born on or after 9/1/04 (2 through 4 year old)
- 20. Senior Dry Cow – born on or before 8/31/04 (5 years and older)
- 21. 125,000 lb Cow – Certified by DHIA Supervisor
- 22. Senior and Reserve Senior Champion
- 23. Grand and Reserve Grand Champion
- 24. Type and Production (must be DHIA or DHIR certified) with official cow sheet attached to P/T form.
- 25. Produce of Dam – two animals: one or more owners; same dam
- 26. Dam and Offspring

SPECIAL CLASSES – All breeds will compete against each other in the following classes.

- 27. **SUPREME CHAMPION** – The Grand Champion of each breed will return to the ring. A Supreme Champion will be selected. The Supreme Champion will receive \$100.00 and a Trophy.
- 28. Best three females – Bred and owned by family exhibitors and residing on same farm; one group per farm.
- 29. Dairy Herd – three animals owned by family exhibitor and residing on the same farm.
- 30. Junior Get-of-Sire – three females all from the same sire born on after September 1, 2007.
- 31. Senior Get-of-Sire - three females all from the same sire born on or before August 31, 2007
- 32. Jersey Special – two animals that are bred, own and shown, born and raised in New Jersey by the same exhibitor who resides in the State of New Jersey

NOTE: All decisions made in regards to the rules and this show by the Superintendent and/or Show Committee are Final.

SHOWMANSHIP CLASSES: YOUTH only animals shown in this class must have been shown in a previous class WITHOUT adult assistance. Ages will go by the age that you turn in the show calendar year. For example: (Your birthday is 10/11 – and you will turn 21. You are showing as a 21 year old and eligible for class 37 in the youth showmanship class.) The Show Committee reserves the right to adjust these classes.

- 33. Up to 7 years old
- 34. 8 years to 11 years old.
- 35. 12 years to 15 years old
- 36. 16 years to 18 years old
- 37. 19 years to 21 years old
- 38. ADULT Showmanship Class – anyone may enter, however, the animal in this class must have been shown in a type class.
